A leather with natural character and soft wax like feel, A resilient coating has been applied during the finishing process offering ideal stain protection but retaining a natural appearance. (Hide size av. 4.5sqm, thickness ca. 1.0mm)

Natural Leather	Leather is a natural product and the uniqueness of each hide is identified on occasion by growth marks, scars, variations in grain and other natural characteristics which add to the beauty of real leather and should not be regarded as a defect. Due to the natural properties of leather, colour and texture variations between batches may occur.
Care Information	<ul> <li>Wipe away stains with a soft damp cloth as soon as they occur.</li> <li>In depth clean with mild lukewarm soapy water taking care not to soak the leather (soap flakes should be used), this prevents dirt build up.</li> <li>Dust with a soft cloth and vacuum frequently.</li> <li>Futura cleaners and conditioners are available to help maintain this type of leather.</li> </ul>
Precautions Protect from / Avoid	<ul> <li>Sources of excessive heat, i.e. fires or close to radiators</li> <li>Direct sunlight particularly on aniline and semi aniline types</li> <li>Furniture polishes and waxes</li> <li>Household detergents and solvents</li> </ul>
